## 1. General description

The 74HC11; 74HCT11 is a triple 3-input AND gate. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of  $V_{CC}$ .

- CMOS low power dissipation
- High noise immunity





Fig. 1. Logic symbol








Fig. 6. Package outline SOT108-1 (SO14)




Fig. 7. Package outline SOT402-1 (TSSOP14)
